Net Banking Charge	Rs.17 /- per Transaction + applicable service taxes for transactions of (SBI/ HDFC) bank. Rs.12 /- per Transaction + applicable service taxes for transactions of (AXIS/ICIC/YES) bank. Rs.7 /- per Transaction + applicable service taxes for transactions of banks not mentioned above. (to be collected from the Parents)
Credit Card Charge	1.05%(Visa, Master ,Maestro) of the Transaction Amount + applicable service taxes (to be collected from the Parents)
Debit Card Charge	0.15% for the value up to Rs.2000/- of the Fee Amount + applicable service taxes (to be collected from the Parents)
	0.90% for the value above Rs.2000/- of the Transaction Amount + applicable service taxes (to be collected from the Parents)
UPI	Rs.11/- per Transaction + applicable service taxes for transactions for all banks. (to be collected from the Parents)
Applicable GST = 18% of the transaction charges for all types of transactions (to be collected from the Parents)
